This is a contract between EZ Obedience & boarding and the pet owner whose signature appears below (Hereinafter called owner)

- EZ Obedience & boarding hereinafter referred to as the "Kennel", agrees to exercise due and reasonable care to keep its premises sanitary and properly enclosed
- Owner agrees to pay the rate for boarding in effect on the date the pet is checked into the Kennel. And further agrees to pay all costs and charges for special services requested and all Veterinary cost for the pet during the time said pet is in the care of the Kennel.
- EZ Obedience & boarding does not assume and shall not be held responsible for any liability with respect to the pet listed in this agreement, of any kind whatsoever, arising out of or from the boarding of this pet, or any damages which may accrue from any other cause whatsoever, including loss by fire, theft disease, running away, death, injury to persons, animals or property or death or injury to any other animal caused by within named pet during the term of this contract.
- Owner agrees to pay to Kennel \$17.00 per dog per night, and \$10.00 for additional dog per night in same kennel.
- The Kennel shall have and is hereby granted, a lien on the animal for any and all unpaid boarding and/or other charges resulting from the boarding of said animal with the Kennel.
- If the animal becomes ill, the owner shall be notified at once, collect, if possible or such attempt shall be made to notify the owner and if the owner does not immediately inform the Kennel regarding measures to be taken or if the state of the animal's health require quick action, the right to call a Veterinarian or to administer medicine or to give advisable attention within the discretions shall be taken for granted by the Kennel and such expenses being reasonable in amount shall be promptly paid by the owner.
- Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances and that the pet has not been exposed to distemper, parvo, rabies or Kennel Cough with the last 30 days.
- This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and the Kennel for this visit and for all subsequent visits.
